Vide reference (2) above Government of India has released 2nd instalment to the colleges mentioned in the subject line.

In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide D.O.No.32/PSO/FS/2015 Dated 28th October, 2015 for General Category 60:40. revised is pattern the funding Andhra Pradesh comes under the General Category State. 2nd installment under Creation of Universities by Conversion of Colleges in a Cluster for 1 university, New Model Degree Colleges for 1 college, Upgradation of Existing Degree Colleges to Model Degree Colleges for 1 college, Infrastructure Grant to Colleges for 17 colleges, Enhancing Quality and Excellence in Select Autonomous Colleges for 2 colleges, Equity Initiative and, 3rd installment under Infrastructure Grants to Universities for 4 universities, New Model Degree Colleges for 4 colleges, Upgradation of Existing Degree Colleges to Model Degree Colleges for 1 college, Infrastructure Grant to Colleges for 15 colleges at the centre: state share of 60:40 to be incurred to the State Government of Andhra Pradesh under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) amounts to Rs. 34,11,60,550/- (Rupees Thirty Four Crore Eleven Lakh Sixty Thousand Five Hundred and Fifty Only). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

- 3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978; as amended from time to time.
